Legal & Ethical Workshop

What Does the Phrase “Standard of Care”
Mean to You? (6 Hours)

Saturday, April 11, 2015 ☼ 9 a.m. to 4 p.m.



Once again we are fortunate to have “our own” Dave Jensen, J.D., an attorney-at-law for CAMFT to teach our annual L&E workshop. He has been a Staff Attorney with CAMFT since April 2002 and consults with its members regarding their legal and ethical dilemmas. Dave gives numerous law and ethics presentations to chapters, schools, and agencies.

Course Description: Dave will review the ten fundamentals of the psychotherapy profession, and he will also address the laws pertaining to the standard of care, especially with regards to suicidal patients, including reviewing actual legal cases involving these issues; obtaining continuing education units, and the fundamentals of reporting elder and dependent adult abuse.

Learning Objectives:

This workshop is designed to help you:

- ★ Identify the ten fundamentals of practicing legally, ethically, safely and confidently.
- ★ Develop a working knowledge of the standard of care and how it relates to psychotherapists.
- ★ Understand what does and does not count as continuing education credit.
- ★ Explain the fundamentals of reporting elder and dependent adult abuse.

This course earns six CEUs and satisfies the BBS requirement for law and ethics for MFTs and LCSWs. Completion of this course earns a discount on liability insurance. You will receive a certificate at the end of the workshop. Look for the brochure at our January meeting—you can mail in your registration or register online beginning in January 2015.

Looking toward 2015

As the year draws to an end, it naturally calls out as a time for reflection as well as re-dedication to future hopes and ambitions. When I joined the local Central Coast CAMFT board about a year ago, I didn't know what would be in store for me or how exactly I could be an asset to local therapists. What soon became clear to me was that I wanted to focus my efforts on pre-licensed therapists, in part because of my own sense of struggle to find a community dedicated to this unique journey.

The process of becoming a therapist is like nothing I'd ever imagined, both incredibly challenging and rewarding, and it's difficult to describe or help others comprehend quite what this process entails and asks of us, without actually going through it. As I write this last sentence, the sing-song lyrics to the children's tale *We're Going on a Bear Hunt* come to mind, with the repeated mantra:

**“Can't go over it.
Can't go under it.
Can't go around it.
Got to go through it!”**

With the many ways we are tested and asked to directly examine ourselves, our fears, our insecurities, and our pasts, there is no other way than to just, “Go through it...”

But we're not alone on our journey. That's where the support and guidance of others on this “hunt” come in. Since May of this year, the Pre-Licensed group of the Central Coast CAMFT Chapter have gathered on four occasions to learn, process, support, and grow with one another. Prior to this, our local pre-licensed therapists had not recently had regular support offered specifically to them in this way. Thus far, I've received some wonderful feedback about the meetings. My vision for this part of the chapter is still in its infancy but, I'm thrilled to have heard from several of those whom have attended, that, “This is what I was missing!”

I continue to learn from these incredible pre-licensed therapists as to what their needs and desire are from their chapter. I've very recently become licensed myself, and want to help others reach this goal, among others. Receiving a license to practice is a tremendous accomplishment, but does not ultimately define or dictate the therapist we become. That growth process extends far beyond licensure and is a part of our ongoing development as clinicians and as individuals. I want to help to establish a strong foundation early on for pre-licensed therapists, fo-

cused on collaboration and support of ourselves and others in building a cohesive and healthy community of therapists in SLO County.

My renewed vision and dedication is to provide these therapists with a place to learn, grow, challenge themselves, and receive the support that can sometimes only be found outside of our agencies, practices, and supervision.
