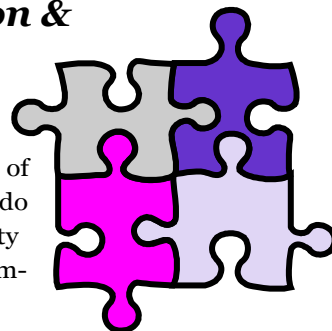

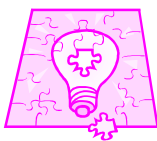


You are invited to bring food to share with others—it's not a requirement, but it most certainly adds to the fun when we have a variety of selections!

- Join or renew your membership in your local CAMFT chapter.

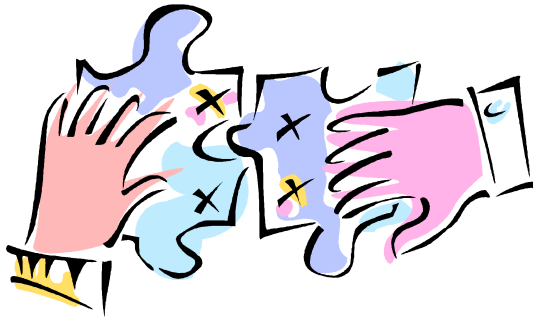

September Program Review:

The Dance of the Mind & Body

Our November program was a very informative look at mental health symptoms from a physiological perspective. Zoe Wells, N.D. presented information on optimal hormonal balance and the impact of imbalances on the mental/emotional system. Dr. Wells is a naturopathic doctor in San Luis Obispo.

While her training is medical in nature, treatment approaches include the use of cranial/sacral therapy, herbal tinctures, bio identical hormones and homeopathic remedies. She explained that some of the symptoms experienced during perimenopause, menopause and andropause (male menopause) include depression, anxiety, sleep disturbance,

low energy and poor concentration. While she did not “advocate” the use of hormone replacement therapy she explained that bio-identicals are similar at the cellular level to our own cells, thereby effectively addressing symptoms with little or no side effects. She emphasized the personal decisions of each patient based upon their medical history and decision to treat symptoms. She also explained that she approaches treatment from a whole person perspective taking in account their nutritional habits, work and exercise routines, etc. Dr. Wells also treats cancer patients undergoing radiation and chemotherapy.

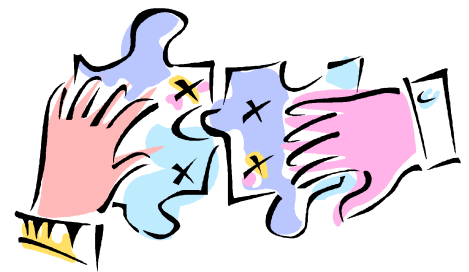
