March 25th Presentation:

Understanding Bipolar Disorder

Our March speaker is Dr. Elisa Feingold, D.O.

Dr. Feingold will discuss some of the challenges involved in diagnosing the various forms of bipolar disorder, including the common comorbid conditions that can greatly complicate the assessment. Except when a classic manic episode can be identified, a clear diagnosis of bipolar disorder generally requires longitudinal observation and assessment. She will also review the best established medication regimens and discuss the increasingly frequent use of the atypical antipsychotic medications.

The discussion of bipolar disorder will also include the importance of education and therapy early in the course of treatment.

Dr. Feingold completed her undergraduate degree at UC Berkeley in 1981. After a brief career as a starving artist, she earned her medical degree at the University of Medicine and Dentistry of New Jersey-School of Osteopathic Medicine in 1989. She interned at USC Medical Center in the Department of Internal Medicine and trained in psychiatry at UC San Diego. She is Board Certified in psychiatry and held special certification in Forensic Psychiatry. She has been in private practice in San Luis Obispo since 1994.

Dear Colleagues,

Your CCC CAMFT Board adopted the **North County Women's Shelter (NCWS)** as its non-profit organization for 2011. I was not even able to attend the meeting so my "bias" toward this wonderful organization did not influence the Board's decision. There are two organizations in our county that serve victims of domestic violence: the Women's Shelter Program of SLO and the North

County Women's Shelter. The North county organization provides the MAJORITY (32) of shelter beds for the entire county.

In our work we have all had occasion to refer clients and the public to these agencies. Obviously the budget cuts have severely impacted the NCWS.

President's Message & Leadership Conference Reports

Hello Everyone,

Three of your board members just returned from the CAMFT Leadership Conference held in Costa Mesa this year. Tammy Summers, Judith Stern, and I were fortunate enough to be able to go and network with 21 of the 29 chapters represented this year.

Mary Riemersma, CAMFT's Executive Director, opened the session with an update on the LPC grandfathering controversy. She informed us that the BBS hired an expert to determine the differences between the MFT and the LPC licenses in order to see if testing would be required. The expert found that there were no significant differences and the BBS voted unanimously that MFTs would be grandfathered in without having to take a test. However, the BBS reversed its decision after it conducted a closed-door meeting with representatives of AAMFT—CA. In a suit brought by CAMFT, a judge has upheld one of the three points made by CAMFT. This, in effect, brings us back to the original decision. However, it's not over yet. CAMFT will continue to fight for us in this arena.

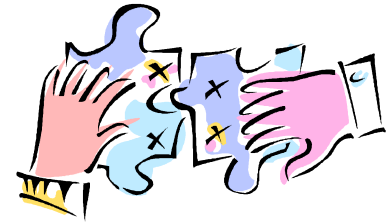
Tammy and I attended the Presidents' forum and the Legal and Ethical breakout session, and Judy went to the Membership and Marketing sessions. Many ideas for marketing, raising awareness of our organization, and legal reminders were brought forward. I was able to speak with Miranda Palmer from the Valley Sierra Chapter about their Speakers Bureau, an idea our board has begun to entertain. She gave me some great ideas.

In keeping with our theme this year of connection, the three of us were

able to meet and connect with new friends and colleagues from around the state. We met many members of the state board of CAMFT and heard their ideas for CAMFT and its future. These are exciting times for our organization and our profession. I hope to see many of you at our future meetings in order to get to know you better and to learn from each of you.

The Leadership Conference took place in Costa Mesa this year. In an effort to take into consideration the size of our state, CAMFT changes the location of the conference each year. Last year it was held in northern California. After Mary Riemersma's opening remarks, each table in the large conference room was allowed to choose a topic for open discussion. Some of the participants came with prepared topics, others created them on the fly. The topics included: How to Pitch to Sponsors, Communication between the State CAMFT Board and the Chapter Boards, Trauma Response, Websites and Social Networking, and how Chapters can interface with their local Universities.

I sat in on the last topic in the hopes of trying to find a way to help our pre-licensed group to grow. A representative from Phillips Graduate Institute was at the table. She said that most schools belong to the MFT consortium of California. Found on PGI's website is this statement: "The Consortium unites the regional consortia of MFT academic programs throughout California with the mission of enhancing the quality of clinical training to MFT students. MFT educators examine the various protocols schools use in preparing students for practicum training and

collaborate with the community clinical sites that provide the direct clinical experience and supervision to the students. These regional consortia have been “effective in promoting the quality of practicum training for students pursuing a career in marriage and family therapy [and] in advancing the integrity of the profession and the participation of its members in local and state governance” according to an analysis reported in Phillips’ Progress Journal, 2006.”

Utilizing students in the MFT track program in the local university as representatives or liaisons between the local chapter and the school was another idea put forth. An intern at the table said that many schools have job fairs. She said at her school, the local CAMFT chapter set up a booth and handed out membership packets furnished by CAMFT. She said many students are not aware of the opportunities offered by CAMFT and the local chapters. Bringing that awareness to Cal Poly students will be one of our goals this year in our efforts to connect with the future of our profession, the interns.

This type of networking with other chapters was most beneficial for bringing new ideas to our pre-licensed program. With the help of our trainees and interns, and the encouragement of our licensed clinicians, we should be able to connect with more students in the MFT program at Cal Poly.

Remember; don’t let yesterday’s sorrows impair your vision of today’s possibilities!

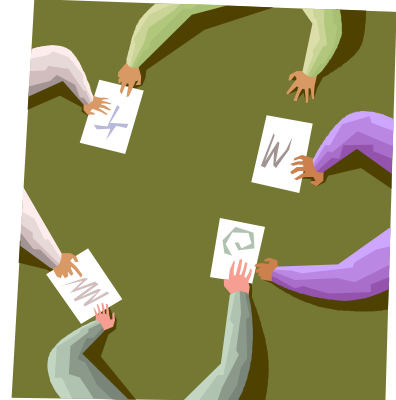

Law & Ethics Workshop: What Does the Law Expect of Me?

Dave Jensen has been a Staff Attorney with CAMFT since April 2002. He was born in Flint, Michigan, but was raised in Tustin, California. Dave graduated from Brigham Young University with a Bachelor's Degree in History, and he received his law degree from the Thomas Jefferson School of Law in San Diego, California. Dave passed the California bar examination in February 1999, and he did it on his first try! Before joining CAMFT, Dave worked for Foley & Lardner, a large national law firm, where he regularly established and advised non-profit organizations. As an attorney with CAMFT, he consults with its members regarding their legal and ethical dilemmas, and he is a regular contributor to *The Therapist* magazine. Dave gives numerous law and ethics presentations to chapters, schools, and agencies, and his popular *What Does the Law Expect of Me?* series, which includes Parts I, II, III, and IV, have helped therapists to better understand their legal and ethical obligations.



What Does the Law Expect of Me? Part I

As a psychotherapist you have probably heard references to the "standard of care" or the "reasonably competent therapist," but you may not have a clear understanding of how such concepts affect you on a day to day basis. Consequently, you may not have an accurate understanding of what the law expects of you as a psychotherapist. In this six-hour workshop, which is Part I of a multi-course series on the subject of the law's expectations for psychotherapists, you will learn about what

the law has to say regarding a therapist's obligation to be a competent practitioner; the importance of properly assessing and diagnosing your patients; the right to privacy, which includes the subjects of confidentiality and privilege; patients dangerous to themselves; patients dangerous to others; and, dual relationships.

This is a lecture-format course that will draw on actual law cases to teach the underlying principles, and it will satisfy the BBS's on-going requirement of six (6) CEUs in law and ethics.
