Our March topic addresses an aspect of the oft-expressed concern of therapists who are faced with the challenge of learning that their clients are abusing substances when substance abuse is (1) not the issue for which the client entered therapy, (2) not the specialty of the therapist, or (3) not an area in which the therapist has particular interest or experience. All too often drug and alcohol specialists hear “well, s/he smokes pot/drinks regularly but it’s not really an issue we focus on in therapy.” How can a mind-altering substance consumed regularly by your client *not* be an issue of focus in therapy—a primary one at that?



Therapists need to be aware of the pitfalls when they are working with clients—particularly adolescents and teens—who may be attending sessions in an “altered state,” or for whom regular substance use has become so much a part of their daily lives that they no longer recognize that it may have replaced optimal coping skills and indeed have arrested their development of these skills. *This is particularly true with adolescents and teens, whose brains are in crucial and critical developmental stages.* Substance use in-

quiry needs to be included in the intake interview of any client.

Several of our members recently expressed the need for a training specific to teens and substance use.

Our March presenters are from the Prevention, Intervention and Treatment departments of San Luis Obispo County Drug and Alcohol Services and will be answering some of our members' questions, including:

- What specific interventions can be used for kids using heroin?
- How can we stop the sale of heroin in the schools?
- What are the confidentiality issues if we report who is selling it?
- What do we tell parents of kids who are using drugs or alcohol?
- What is the latest research on pot as an entry drug and its long- and short-term effects on the brain?

While alcohol is still the number one drug of choice of teens and marijuana is used by many teens in our

BBS News: Examination Restructure



SB 1575 (Chapter 799, Statutes of 2012) was signed by the Governor on September 29, 2012. This bill changes the effective date of the Board's upcoming restructure of its examination process from January 1, 2013, to January 1, 2014. Further information can be found on the 2012 Approved Legislation.

Test Vendor Information

Psychological Services, LLC (PSI) schedules and administers the Board of Behavioral Sciences licensing examinations. Once the Board determines that you are eligible to sit for an examination, you will receive a candidate handbook from PSI within two weeks. The handbook will contain the necessary information that you will need to schedule your appointment as well as the procedures for scheduling.

If you are a **FIRST TIME APPLICANT** your examination eligibility expires one year from the date of original eligibility. If you are a **RE-EXAMINATION APPLICANT** your eligibility expires one year from the date of your last exam. Your eligibility information can be verified by contacting the Board.

When scheduling you will need to provide PSI with your name, social security number, and file number. If you are currently eligible and have not received a candidate handbook within two weeks of your initial eligibility date, are unsure of your file number, or if you have problems or difficulties when scheduling or taking an exam, please contact the Board at (916) 574-7830.

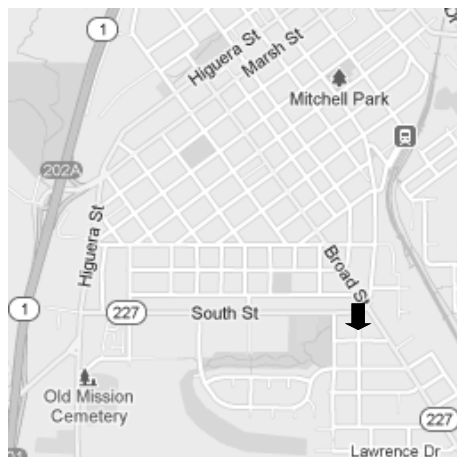
